Road Traffic Regulation Act 1984

Notice is given that KENT COUNTY COUNCIL, acting as Local Traffic Authority and in exercise of its powers under sections 81, 82, 84 and 124 of the Road Traffic Regulation Act 1984, (hereinafter referred to as the Act) and all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby propose to make the following order.

The effect of the order would be to extend the current speed limit of 30MPH on the following length of roads in Walmer, Dover:-

COLDBLOW - From its junction with Ellens Road and Station Road for a distance of 10 metres in a southerly direction. **CROSS ROAD -** From its junction with Ellens Road and Station Road for a distance of 260 metres in a northerly direction. **ELLENS ROAD -** From its junction with Station Road and Cross Road for 20 metres in a westerly direction.

- This Order shall come into operation on day of and may be cited as 'The Kent County Council (Various Roads, Dover) (Speed Limits) (Consolidation) Order 2022 (Amendment No.9) Order 2024' ('this Order').
- 2. The Interpretation Act 1978 shall apply to this Order as it applies for the interpretation of an Act of Parliament.
- 3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, 'The Kent County Council (Various Roads, Dover) (Speed Limits) (Consolidation) Order 2022' ('the Order of 2022') shall have effect as though:
 - (a) Schedule 2 to the Order of 2022 is amended by the replacement or the issue of the following Map Tiles:
