22. OPENNESS AND TRANSPARENCY

The Chairman read out the statement published in the agenda.

23. CHAIRMAN'S REPORT

- i. The Chairman welcomed Cllr Mark Simpson to the council. As a newly elected councillor Cllr Simpson has already participated in a number of committees and the Jubilee event.
- ii. The Jubilee celebrations and Food and Drink festival were very successful despite the weather. The Chairman offered his thanks to all involved. Both artists and stall holders have expressed a wish to work with Walmer Town Council again.
- iii. The Chairman also attended the beacon lighting at the cricket club. The event was well attended with approximately 400 people either in the ground or on the road outside.

The meeting was a series of presentations covering planning, Ukrainian refugees, electoral changes, fly tipping and noise pollution. The newly appointed Head of Planning Sarah Platts indicated that she would be happy to meet with the Walmer Town Council Planning Committee and the Clerk has organised a meeting. An update on the Local Plan timetable was given and this should go before the Dover District Council Cabinet in October for approval. The Elections Act 2022 has just received Royal Assent

and some of the provisions, like voter ID at polling stations, will be in place by the 2023 elections.

Cllr Le Chevalier very quickly intercepted them and asked them to stop and security then safely escorted the car off the green. The same people then came back to the event and were causing some issues at the doughnut vendor. They were asked to leave the event and complied.
